

PUBLIC OFFER AGREEMENT  
On the Procedure for Publishing Authors' Articles in the Journal  
"Psychology and Personality"

Section 1. Scope and Access

1.01. This Public Agreement (hereinafter – the Agreement) establishes the procedure for the publication of authors' articles in the journal "Psychology and Personality."

1.02. The Agreement is addressed to an indefinite number of persons and applies to each author who has accepted its terms.

Section 2. Public Offer

2.01. This Agreement constitutes a public offer in accordance with Article 633 of the Civil Code of Ukraine.

2.02. The publication of this Agreement on the official website of the journal constitutes an offer to conclude the Agreement under the terms set out herein.

Section 3. Accession (Acceptance) and Preconditions

3.01. The Agreement is concluded by the Author's full and unconditional acceptance of its terms, without any reservations or amendments (Article 642 of the Civil Code of Ukraine).

3.02. Prior to acceptance, the content of the article shall be preliminarily agreed between the Author and the Editorial Office.

3.03. The act of acceptance is deemed to be the Author's submission of materials for publication in the Licensee's editions.

Section 4. Parties and Roles

4.01. The Author is a natural person who has created an article and submitted it for publication; within this Agreement — the Licensor.

4.02. The Publisher/Editorial Office of the Journal is the organisation that performs editorial processing and publication; within this Agreement — the Licensee.

Section 5. Licensing Model and Scope of Rights (CC BY)

5.01. The Author retains all personal non-property and property (economic) rights to their work.

5.02. The Author grants the Licensee the right of first publication under the terms of the Creative Commons Attribution International Licence (CC BY), within which the Licensee is authorised to:

- a) publish articles in English and distribute printed versions;
- b) translate articles into English (for manuscripts submitted in Ukrainian) and distribute printed translations;
- c) distribute electronic versions of articles and their English translations (for Ukrainian-language articles) by any electronic means, including the journal's official website, electronic databases, and repositories.

Section 6. Confirmation of Acceptance and Allocation of Rights

6.01. The act specified in Clause 3.03 (submission of materials) constitutes acceptance of the Agreement.

6.02. The publication of the author's material in the Journal "Psychology and Personality" confirms the allocation of rights between the Licensor and the Licensee.

Section 7. Liability of the Parties

7.01. In the event of failure or improper performance of obligations, the parties shall be liable in accordance with the current legislation of Ukraine.

7.02. Nothing in this Agreement limits the right of either party to protect its interests in the manner prescribed by law.

Section 8. Dispute Resolution

8.01. Any disputes or disagreements arising in connection with the execution of this Agreement shall be resolved through negotiations between the parties.

8.02. If no agreement is reached, the dispute shall be settled in court in accordance with the legislation of Ukraine.

#### Section 9. Final Provisions

9.01. In matters not expressly regulated by this Agreement, the parties shall be governed by the legislation of Ukraine.

9.02. Any updates to this Agreement shall take effect from the moment of their publication at the address specified in Clause 1.03.

9.03. The Agreement enters into force for a particular Author from the moment of acceptance, as defined in Clause 3.03.
